Purpose

The June 10, 2020 CEES meeting will begin by closing out the Solar PPA project and conclude by brainstorming future projects/initiatives.

Agenda

1. Call to Order

Heather Abbott brought the meeting to order at 7:05pm. Toby Ahrens made a motion to accept the May 6, 2020 meeting minutes. The motion was seconded by David Ertz and passed without comment.

2. Solar PPA Follow-Up

David Ertz began by providing a preliminary review of the draft Power Purchase Agreement submitted to the Town by ReVision. Overall, the agreement was straight forward, but there were two adjustments to their original proposal. First, since submitting the proposal, ReVision learned of an additional transmission study for their Sidney facility. The transmission study was prompted by several projects being planned in the same transmission territory. However, even with a potentially delayed timeline, ReVision's proposal was still the most aggressive. ReVision also mentioned that the performance guarantee that was included in their proposal may be adjusted based on their partner investor. Performance guarantees are not allowed if the investor is utilizing USDA Rural Development funds. The Committee agreed that it was in ReVision's best interest to have a productive system and felt comfortable moving forward.

Scott LaFlamme reported that ongoing discussions with ReVision have been positive, and the Town's attorney is negotiating final details with ReVision's representation. S. LaFlamme expects the agreement to be completed soon.

3. Brainstorming: Next Steps

Prior to the discussion, S. LaFlamme asked Councilor Humphrey to clarify the Town Council's intent of the Committee. Specifically, was the Committee meant to focus on energy-related policy or a broader sustainability focus?

David Craig and A. Humphrey gave historic context of the committee and general guidelines for future projects. Both felt that as the group has matured, new projects should be pursued with Town Council being informed.

H. Abbott opened the discussion for brainstorming ideas. D. Craig began by introducing the idea of **rehabilitating the Royal River and its fish habitat**. S. LaFlamme provided some context regarding work being completed by the Army Corps of Engineers. D. Craig suggested that the committee would be the best suited group to review the Army Corp report and provide stakeholder outreach. T. Ahrens recommended that since this topic will certainly become controversial, should CEES take on the review it should be done transparently as possible. The group generally agreed with helping develop the technical reporting was worth exploring, should the Town Council decide to assign it to the committee.

Prior to the meeting, Kurt Adams suggested looking at how the Town could mitigate and harness excess methane at the Wastewater Treatment Plant. Unfortunately, K. Adams was not present, but there was a brief conversation among the committee. The group felt that further exploration is needed. S. LaFlamme was tasked with working with Steve Johnson, Town Engineer, on their outstanding questions.

Community Solar: Group generally agreed that this could be reconsidered. With the economics seen through the PPA, the committee agreed that it makes sense to investigate. The committee suggested looking at the Sligo Road property again, in hopes of partnering with a for-profit entity who might be willing to take on CMP's liability. There was a sense of urgency from the group to move forward on additional solar projects so that residents could take advantage of the 26% (22% in 2021) federal tax incentive.

4. Adjourn

The June 10, 2020 CEES meeting adjourned at 8:30pm upon mutual consent.
